STARTER DIVISION:

Dressage: Starter-2015 USDF Introductory Test C.

Cross Country: Not to exceed 2'5" : most smaller.

1400m-2000m @ 250 mpm – very inviting course; water pass through with option; no open ditches

Stadium: 250 mpm, jumps not to exceed 2'5": Timed

Safety vests must be worn on Cross Country
